New Business</p> <ul style="list-style-type: none"> Announcement of the new law regarding infant safe sleep and the new online grief training announced by Tomorrow's Child Logic Model Leadership Elections 	<p>On may 14, 2014, Gov. Snyder signed legislation designed to help lower infant mortality in Michigan—House Bill 4962, now Public Act 122 of 2014. The bill requires hospitals and health professionals to provide parents readily available information and educational materials regarding infant safe sleep practices following the birth of a child. The materials must also explain the risks associated with unsafe sleep environments. More information is available at www.michigan.gov/safesleep.</p> <p>A description of the Logic Model was provided. Regina Traylor proposes this be a guide to development of the Infant Mortality Coalition Work Plan. General agreement was expressed by those present.</p> <p>Discussion initiated by Regina Traylor. Currently there are 2 Co-Chairs for the group as agreed upon by the coalition members. 1 Co-Chair is a Health Department Representative, 1 is a Community Agency representative. Both have served since January/February 2013. Regina asks the membership to identify how long should the co-chairs serve?, How should they be selected. Discussion took place about length of service. Most members appeared to agree that it should be a 2 year term but staggered so that a new co-chair is identified each year to be guided by the co-chair in their second year of service.
