





Q10: Where was your child enrolled?





Q13: How satisfied were you with the overall enrollment process? (Including friendly customer service, effective communication, enrollment timeline, explanation of program options, etc.)



Comments: Strong points

"Excellent program & very well organized. My daughter loved it!"

"In general this has been a very positive experience, I have worked with great staff who are supportive and provided a great deal of useful information and resources. Thanks for all your help."

"Everyone I have encountered thru ... from enrollment to the teachers I've had nothing but good experiences! I love this program and I'm so grateful that my daughters had the opportunity to attend."

"The process was quick and done within days of my submission. Only if I was informed that soon:)"

"Thank you, made the process very easy."

"The ... Program does a wonderful job communicating with all parents, through out the whole process of enrollment."

Comments- Areas of Improvement

- "Any communication on the matter of the application after staff stated they lost it and then found it again should have been expected, but never occurred. When I called back to found out the status of the application I was directed to two different people both of whom never returned my phone calls to follow up on my daughters application."
- "No contact made and no phone calls returned."
- "Bad communication, impatient staff, didn't get enough information back."
- "Contact with the families who applied. I contacted the main office numerous times to see if my daughter would attend one of the programs and left numerous messages. My calls were never returned and my questions were never answered. The only answer I could get was that my daughters application has been received."
- "We did not receive final paperwork until the week it was due. Earlier notice would be helpful."
- "Any enrollment information via email, or mail. Everything was communicated through the phone."
- "The starting time for when school started and ended prior to the open house so that way I could of put my child on a sleep schedule."
- "I was disappointed at first to find out only a week before school was starting what the schedule was going to be. In the end it worked out better for my family but it was quite inconvenient as I needed to request the change in hours at work and I was not given enough time to do that."
- "Enrolling in GSRP made me feel very poor, very uneducated, treated horribly. The staff and program are amazing, enrolling was terrible."
