

**Sample Good Cause Exemption Letter from Parents to Superintendent**  
**Warqad sabab muunad wanaagsan ee looga dhaaf ee ka socota waalidka kuna socota Taliyaha**

Dear Superintendent:

Mudane Maamule:

I have received a letter from the state of Michigan informing me that my child will be retained in grade three for the upcoming school year. I am formally requesting that you consider the following Good Cause Exemption qualifications on behalf of my child:

Waxaan helay warqad ka socota gobalka Michigan oo igu wargelineysa in cunugayga uu ku noqon doono fasalka seddexaad sannad dugsiyeedka soo socda. Waxaan si sharci ah horay ugu codsaday in aad tixgeliso Asbaabaha Wanaagsan ee Loogu Dhaafi karo sharuudaha soo socda annoo ka wakiil ah cunugayga:

- Cunugayga wuxuu leeyahay IEP.  
My child has an IEP.
- Cunugayga wuxuu leeyahay qorsho 504.  
My child has a 504 plan.
- Cunugayga waa xaddidan tahay kartida Ingiriiskiisu.  
My child is limited English Proficient.
- Cunugayga wuxuu helay ku luglahaansho u baahnaan aqrin ee labo sanno ama in ka badan laakiin weli muujinaaya ku yaraan aqrin iyo kal hore oo lagu celiyay xannaanada caruurta, fasalka koowaad, fasalka labaad ama fasalka seddexaad.  
My child received intensive reading intervention for two or more years but still demonstrates a reading deficiency and was previously retained in Kindergarten, grade one, grade two or grade three.
- Cunugayga wuxuu ka diiwaan gashanaa degmada xoogaa kaddid labo sannadood waxaan jira cadeyn in cunugayga aanan la siinin Qorsho Horumarin Aqrin Shaqsiyeed ku haboon (IRIP).  
My child has been enrolled in the district for fewer than two years and there is evidence that my child was not provided with an appropriate Individual Reading Improvement Plan (IRIP).
- Cunugayga wuxuu muujiyay karti u lahaansho dhanka xisaabta ee qiimeyntii dowlaa wuxuu kaloona muujiyay karti u lahaansho dhanka syniska iyo waxbrashda bulshada sida lagu muujiyay warbixin-qoraaleedkii sida ay macallika go'aamiyay kaasoo siiyay cunugayga casharka fasalka seddexaad.  
My child has demonstrated proficiency in math on a state assessment and has demonstrated proficiency in science and social studies as shown through a pupil portfolio as determined by the teacher who provided the grade three instruction to my child.
